

Raigad from the academic year 2012-13.

In this connection, I am directed to inform you that, considering the permission granted by the Government of Maharashtra to your Society as per the Government Resolution (G.R.) and प्रमाणपत्र referred to above, I am pleased to inform you that your Society has been granted for first time affiliation to open a new degree college to start B.A., B.Com., B.Com.(A&F.), B.Com.(B.&I.), B.M.S., B.Sc., B.Sc.(I.T.), B.Sc.(C.S.) degree courses on the name of St. Wilfred College of Arts, Commerce and Science at At: Shedung, Tal.- Panvel, Dist. Raigad on permanently, 'No Grant Basis' to start the first year classes only of B.A., B.Com., B.Sc., with intake of 120 students in each class and B.Com.(A&F.), B.Com.(B.&I.), B.M.S., B.Sc.(I.T.), B.Sc.(C.S.) with intake of 60 students in each class degree courses from the academic year 2012-13.

The college has to fulfill the conditions mentioned in the above mentioned Government Resolution (G.R.) and प्रमाणपत्र of the Government of Maharashtra.

The college has also to fulfill the following affiliation conditions -

- 1) that the conditions laid down by the University from time to time.
- 2) that the minimum attendance of all the students must not be less than 75% during the academic year and college will have to complete syllabus of all the subjects during the academic year.
- 3) Admissions should not be taken with donations.
- 4) that they will strictly follow the Ordinance 2802 in respect of preventing the colleges and Management of Colleges from accepting donation or capitation fees for admission of students in the Colleges, quoted in the University Circular No.Aff./Recog./49 of 1987 dated 4<sup>th</sup> February, 1987 (copy enclosed).
- 5) that they should follow the norms as prescribed and circulated by the University vide No.CONCOL/75 of 1988, dated 3<sup>rd</sup> March, 1988 (copy enclosed).
